ABOUT US

The Child Advocacy Center is a non-profit organization providing a safe, child friendly location for conducting forensic interviews and medical evaluations for abused children in Southeast Nebraska.

We opened in 1998 and since that time have served 16,000 child victims of abuse and neglect and their non-offending family members. Our staff of 20 respect the courage it takes for a child to tell and nothing is more important for us than creating an environment that is safe and supportive. We understand what we do matters. Our goal is to create a safe space for children and families to share their truths and rebuild their lives so future generations may not have to.

We are a fully accredited member of the National Children's Alliance serving 17 counties with offices in Lincoln, Auburn and York on an annual operational budget of \$1.5 million dollars. Our funding sources are varied and include individual and corporate donors, special events, grants and foundations, as well as state and local government funding. Through the efforts of our staff and volunteers, including our founding Executive Director in partnership with our Board of Directors, we have established ourselves as an organization that can and does make a difference for children and families in our community.

We also recognize that we work as part of a multi-disciplinary team with law enforcement, Health and Human Services, medical personnel, mental health providers

and prosecutors. We strive to operate in a work environment that is marked by honest, responsible and open communication. As a team, we support each other in a very difficult and demanding job.

In the last 20 years, our founding Executive Director has given us the building blocks for success. In the next 20 years, we are looking for a strong leader to continue to grow the organization with new energy, ideas and expanded funding.

Our future vision includes a \$3.7 million dollar capital campaign to expand on our facility and services in the next 3-5 years, with emphasis on growing our training and prevention efforts throughout Southeast Nebraska, as well as our on-site mental health partnerships.

The primary office of the Child Advocacy Center is located in University Place in Northeast Lincoln. Lincoln is the capital with a population of nearly 288,000. The city has a historic and vibrant downtown core and is the home of the University of Nebraska. The Lincoln Public School system is one of the premier school districts in the Midwest.
